### How do you collect my data?

Everything is stored on the PC of our responsible employee and also on secure cloud storage. ### What information do you collect that could be used to identify me?

As with many other companies, we collect some personal information that can be used to identify you. This includes likenesses, images, video and audio recordings.

### Do you share my data with third parties?

YES, because we put the records on social networks and other online communication channels that are owned by a third party. We therefore share this personal data with META Platforms (Facebook, Instagram), ByteDance (TikTok), Seznam.cz, a.s. (Firmy.cz) or Google.

### What rights do I have in relation to my data?
